

Privacy Policy and Personal Data Protection

In accordance with Law 15/1999, dated December 13, regarding the protection of personal data, users of this website are informed that Aura Lifestyle complies with the obligations, duties, and guarantees required by the applicable data protection regulations.

Purpose of Data Processing:

Aura Lifestyle will process modification or cancellation requests within ten days. If data is canceled, it will be blocked, but retained for compliance with legal requirements. After the relevant statutory period has passed, the data will be fully deleted. If any modification or cancellation has already been communicated, Aura Lifestyle will notify the relevant parties.

Obligations Regarding Data Provided by the User:
